DIACAP BACKGROUND

It is DoD policy that all information systems undergo a Certification and Accreditation (C&A) process. *Certification* is a technical analysis of the system’s compliance with an assigned set of Information Assurance (IA) Controls (i.e., security requirements, derived from DoD Instruction 8500.2 and other policies), thereby providing an assessment of the system’s risk level. *Accreditation* is a formal Approval To Operate (ATO), granted by a senior government official, who determines the risk is acceptable on the basis of information collected during the certification.

DIACAP (DoD Information Assurance Certification and Accreditation Process) is the name given to the formal process for certifying and accrediting information systems within the Department of Defense. DIACAP roles and responsibilities, process steps, and documentation deliverables are detailed in DoD Instruction 8510.01.

THE PROGRAM MANAGER’S DILEMMA

The Program Manager/System Manager’s primary responsibility is to oversee the development and maintenance of a system that fulfills its stated mission. However, in order for the system to be put into operation, it must receive accreditation. The Program Manager must therefore ensure the appropriate DIACAP activities are integrated into the system life cycle. Usually there is a support contractor in place to provide system development and integration services, but additional Information Assurance support is often needed to oversee DIACAP activities.

In response to this need, the DIACAP Resource Center is pleased to offer DIACAP consulting services to DoD program and system managers.

DIACAP CONSULTING SERVICES

Our DIACAP consulting services include, but are not limited to, the following:

- Supporting the Program Manager in identifying key personnel, forming a DIACAP team, and conducting a successful DIACAP “project kickoff”
- Supporting the DIACAP team in determining the Mission Assurance Category (MAC) and Confidentiality Level (CL), selecting and augmenting the Baseline IA Controls
- Supporting the DIACAP team in initiating and executing the DIACAP Implementation Plan
- Supporting the system development team in design/implementation of assigned IA Controls



- Developing documentation, such as policies, procedures and other “artifacts”, in support of the DIACAP process
- Supporting the DIACAP team in evaluating compliance with assigned IA Controls
- Supporting the Program Manager during the validation and certification process
- Developing the key DIACAP documents, including the System Identification Profile (SIP), DIACAP Implementation Plan (DIP), and Plan of Action & Milestones (POA&M)
- Supporting the Program Manager in maintaining accreditation, conducting annual reviews as required by FISMA, and conducting re-accreditation as required

CONTRACTUAL ARRANGEMENTS AND FEES

DIACAP consulting engagements are normally done on a “time and materials” basis. Based on the size and complexity of systems being certified, and the breadth of desired services, an initial estimated number of hours will be given, and adjusted thereafter based on progress and issues encountered. DIACAP Resource Center can work as a direct contractor to DoD or as a subcontractor to an existing system developer/integrator. Our parent company, BAI, is listed in the Central Contractor Registry and holds a SECRET facility clearance.

DIACAP TRAINING

The DIACAP Resource Center also offers classroom training to government and industry. We currently offer a one-day *DIACAP Fundamentals* and a three-day *DIACAP In Depth* course. Both courses are presented on a regularly-scheduled basis at selected locations nationwide, including the National Capital Region, Colorado Springs, Huntsville, and San Antonio.
